



EVENT INDEMNITY FORM

To: Hampton Downs (NZ) Limited ("Hampton Downs")

and: its parent, subsidiary and affiliate companies (including the land owner) and their respective directors, officers, employees, contractors, agents, and volunteers (collectively the "Released Parties").

Releasing Parties: means and includes the undersigned as well as the undersigned's spouse, children, parents, guardians, heirs, next of kin, and any legal or personal representatives, executors, administrators, successors, assigns, or anyone else who might claim or sue on the undersigned's behalf.

Event: means any motor sport activities or services at the Hampton Downs Motor Sport Park Circuit which are organised or conducted by Hampton Downs or are permitted or approved by Hampton Downs or otherwise under the responsibility/control of Hampton Downs.

I, the undersigned, agree to be bound by the following terms and conditions in favour, and for the benefit of, the Released Parties:

- I certify that:
 - I am at least eighteen (18) years of age and I am the holder of a current full driver's licence **OR** if I am under 18 years of age I certify that I am the holder of a restricted driver's licence and my parent/guardian has explained this document to me and consented to its terms;
 - I am not under the influence of alcohol or drugs or other substances that would in any way impair my ability to safely drive the vehicle; and
 - I am in good in good health and in proper physical condition and sufficiently skilled to safely participate in the Event. I further certify that I have no known or knowable physical or medical conditions that would affect my ability to safely participate in the Event.
- I agree to familiarise myself with and to comply with all warnings and the Occupational, Safety and Health Regulations provided or made available to me by Hampton Downs or its employees, representatives and agents during the Event, including but not limited to the wearing of full safety clothing and gear at all times.
- I agree to comply with all instructions/directions given by Hampton Downs or its employees, representatives/agents during the Event.
- I will not allow any person other than the person named as the driver on this form to drive the entered vehicles.
- I will not enter the Hampton Downs Circuit without first obtaining the Hampton Downs Circuit Manager's permission.
- I agree to exercise all due care whilst attending or participating in the Event.
- I understand and agree that I am expected to exhibit appropriate behaviour and to obey all local, state and federal civil and criminal laws at all times while participating in or attending the Event. I further understand and agree that Hampton Downs, or its employees, representatives and agents can dismiss me, without refund, should my behaviour endanger the safety of or negatively affect the Event, another person, facility or property of any kind, or if I otherwise breach any of the terms in this indemnity form.
- I agree that I will be responsible for and will pay to make good any damage I may cause, whether deliberately or otherwise, to any property of Hampton Downs Motorsport Park.
- I acknowledge that motor racing and motor sport activities are inherently dangerous and there is significant risk of injury, disability or death by attending or participating in the Event. I am aware that if I do not wish to be exposed to such risks, then I should not attend or participate in the Event.**
- I agree to attend or participate in the Event at my own risk. I further agree that to the fullest extent permitted by law I will not hold any of the Released Parties responsible for any damage, injury or death caused by mechanical failure or otherwise of any vehicle supplied by those parties, whether directly or indirectly, or due to the state of the Hampton Downs Circuit.
- I understand and agree that in consideration of me being granting permission to attend or participate in the Event and to use the Hampton Downs Circuit and/ or venue, I warrant all of the above and, to the fullest extent permitted by law, I agree to release, indemnify and hold harmless and keep indemnified each of the Released Parties from and against all actions, claims, liabilities, costs, expenses and demands in respect of my death, physical or mental injury, loss or damage to person or property howsoever caused, arising out of or in connection with my use of a vehicle at the Hampton Downs Circuit, or my attendance or participation in the Event, including claims by third parties, and notwithstanding that such claims may have been caused or contributed to by the fault or negligence of any of the Released Parties.
- The above provisions confer a benefit on, and are intended to be enforceable by, each of the Released Parties (in accordance with the Contracts (Privity) Act 1982. Further, if any of the above provisions are unenforceable, illegal or void then they are severable and the rest of this document will remain in force.
